
## Look to Our History for Courage, Comfort, and Inspiration

# **NEWS**



Your action helped shift the momentum from demolition to renovation!

HKC issued acall to action to stop the proposed demolition of the historic home at 236 W. 54th

St., located in the Simpson-Yeomans/Country Side Historic District. An application was filed with the Preservation Commission by the homeowners to demolish the historic home so that they may construct a new home on the large corner lot.

The community response on social media was overwhelming, reaching over 94,300 individuals, resulting in 31,226 engagements, 382 comments, and shared over 285 times. HKCs'call to action resulted in over 70 individuals submitting comment to the Preservation Commission. Well done!

The homeowner has withdrawn their application for demolition and proceeding with interior abatement. Temporary construction fencing has been installed. A potential future application for a rear addition is possible.

**Background:** On February 26th, HKC first alerted you that an application had been filed by the homeowners to demolish the existing historic home at 236 W. 54th St so they may construct a new home on the large corner lot. The applicant proposed to demolish the house due to deterioration and environmental concerns and the cost to repair those issues. The Georgian-revival style home was designed by the noted architectural firm of Shepard, Farrar & Wiser.

Case #CH-DR-2020-00009 was originally scheduled to be heard by the Historic Preservation Commission on February 28th, it was continued to March 27th at the request of the applicant. That March 27th hearing was cancelled. The Applicant withdrew the case prior to the April hearing.

#### **Webster House Closes**

Another sad outcome of our changing times. The Romanesque style Webster House — a destination draw in the Crossroads with its combination of upscale restaurant and retail in a historic building — will not reopen. Enforcement options were failing; the property was likely a candidate for City Receivership or the Chronic Nuisance program. In partnership with the City, Historic Kansas City placed the



#### Mo Historic Tax Credits

Governor Parson issued the Department of Economic Development (DED) a waiver granting it permission to temporarily suspend certain statutory requirements related to the Historic Preservation Tax Credit during the COVID-19 emergency and subsequent recovery period.
